**Subject : Re-organisation of Service Tax  
Range – Jamnagar.**

The work-load in Service Tax Range – Jamnagar has seen a substantial increase in recent times. For smooth functioning of the Service Tax Range- Jamnagar and to facilitate the Trade, additional officers viz. Superintendent and Inspector have been posted recently to attend to the work of the Range.

In this connection, the Trade and Public are hereby informed that the jurisdiction of Service Tax Range-Jamnagar has been sub-divided into two, for effective administration with the following jurisdiction :

<b>Sr. No.</b>	<b>Sub-divisions of Assessment Range, Jamnagar.</b>	<b>Geographical jurisdiction.</b>
1	Range – I, Jamnagar.	Service Tax Assesseees in the area covered in Municipal Corporation limits of Jamnagar City.
2	Range–II, Jamnagar.	Service Tax Assesseees in the District of Jamnagar (except area covered in Municipal Corporation limits of Jamnagar City) & District of Dev Bhumi Dwarka.

The assesseees falling under the existing Service Tax Range-Jamnagar are requested to transact official work with the officers of their concerned Sub-Division. New assesseees who need to register themselves may contact the officers of the concerned Sub-Division of the Service Tax Range-Jamnagar. The above changes will come into effect w.e.f. 01.07.2014.

All the members of Regional Advisory Committee and the Trade Associations / Chamber of Commerce and Industry are requested to bring the contents of this Trade Notice to the knowledge of their constituent members for information, guidance and vide publicity.


