**Subject : Re-organisation of Central Excise  
Range – Morbi.**

The work load in Central Excise Assessment Range – Morbi has seen a substantial increase in recent times. For smooth functioning of the Central Excise Assessment Range- Morbi and to facilitate the Trade, additional officers viz. Superintendents and Inspectors have been posted recently to attend to the work of the Range.

In this connection, the Trade and Public are hereby informed that the jurisdiction of Central Excise Assessment Range- Morbi has been sub-divided into three, for effective administration with the following jurisdiction :

<b>Sr. No.</b>	<b>Sub-divisions of Assessment Range, Morbi</b>	<b>Geographical jurisdiction.</b>
1	Range – I, Morbi.	Tankara Taluka (entire), Malliya Taluka (entire), Area of Morbi Taluka on west of NH 8-A.
2	Range–II, Morbi	Area of Morbi Taluka falling on East Side of N. H. 8-A comprising area of North Side of Ghuntu Road upto boundry of Kutch on one side and upto boundry of Halvad Taluka on the other side.
3	Range–III, Morbi	Area of Morbi Taluka on East side of the N.H. 8-A between South side of the Ghuntu Road upto boundry of Wankaner Taluka.

The assesseees falling under the existing Central Excise Assessment Range-Morbi are requested to transact official work with the officers of their concerned Sub-Division. New assesseees who need to register themselves / request for export related work, may contact the officers of the concerned Sub-Division of Central Excise Assessment Range-Morbi. The above changes will come into effect w.e.f. 01.07.2014.

All the members of Regional Advisory Committee and the Trade Associations / Chamber of Commerce and Industry are requested to bring the contents of this Trade Notice to the knowledge of their constituent members for information, guidance and wide publicity.


