5. The Committee will meet once in a quarter on the date and time to be decided with mutual consultation. The meetings of the Committee will ordinarily be held at the Commissionerate Headquarters, unless, a different venue for the meeting is decided by the Chairman.

6. Members of the Committee will be entitled to claim traveling allowance and daily allowance in accordance with the existing Government Rules / Instructions.

7. The Committee shall not discuss individual cases, judicial and quasi-judicial matters. Since each Commissionerate of Central Excise has its own Public Grievances Redressal Committee, the points being raised for discussion should, as far as possible, relate to the matters pertaining to the trade falling within the jurisdiction of the Central Excise Commissionerate, Rajkot.

8. The term of this Committee will expire on **31.12.2015**.
