TRADE NOTICE NO.17/2013


Sub.: Creation of special cells in divisions and HQ. office of Central Excise, Rajkot for the purpose of ensuring duty payment on 30/31.03.2013.

As per rule 8 of the Central Excise Rules, 2002 and rule 6 of the Service Tax Rules, 2002, payment of Central Excise duty/Service tax for the month of March is to be made on or before 31.03.2013. However, it is noticed that 27.03.2013, 29.03.2013, 30.03.2013 and 31.03.2013 are public holidays. All the assesseees of Central Excise and Service Tax are to be sensitised to take notice of the above and deposit due tax/duty within the prescribed time limit vide Trade Notice No. 03/2013-CE dated 26.02.2013.

2. In order to ensure payment of Central Excise duty and Service Tax within the prescribed time limit, the banks are separately being requested to keep their branches open for longer hours on 26th, 28th & 30th March, 2013 and for at least half day on 31.03.2013 for the purpose of tax collection. Further, special cells are to be created in divisions as well in HQ. Office of Central Excise, Rajkot to guide & help the assesseees in deposition of duties.

3. The following officers are nominated in each formation, to attend the above mentioned task to ensure timely duty payment during the period. If any assessee has got any difficulty, he may contact the concerned officer, at the contact numbers mentioned against the name of each officer:
