Subject: Implementation of "Service Delivery Excellence Model" called "SEVOTTAM" in Central Excise Rajkot Commissionerate reg.

It is brought to your notice that The office of the Commissioner of Central Excise, Rajkot situated at "Kendriya Utpad Shulk Bhavan", Race Course Ring Road, Rajkot – 360 001 endeavors to implement "Service Delivery Excellence Model" called "Sevottam" whose aim is to enhance customer satisfaction, provide effective and efficient services, continually improve its services and service delivery processes by encouraging, facilitating and assisting existing and potential assesses to voluntarily discharge their tax obligations and provide them services required in meeting their obligations. The Commissionerate commits to discharge all its functions in a fair, impartial, transparent and consistent manner.

- 2. As a measure of achieving excellence in the Service Delivery, the following is decided to be provided in implementing the same immediately in the Headquarter Sections and all Divisions and their formations of the Commissionerate:-
 - "Single Point Service" to the Trade, Industry and other stakeholders where a centralized receipt and disposal systems for all written communications have been established at Office of the Commissioner of Central Excise Rajkot Commissionerate, "Kendriya Utpad Shulk Bhavan", Race Course Ring Road, Rajkot 360001. All written communications should be submitted at the Counter of Centralized Dak Receipt Centre i.e. Single Point Service (SPS). Written Acknowledgement will be issued and handed over by the officials immediately at the time of submission of such written communication simultaneously indicating Field Specific Reference number along with name of concerned field formation where request shall be processed. However, the written communications received by Post or Courier, acknowledgement shall be sent by post within seven days. This office shall try to meet the standards of services promised under the "Citizen Charter" and disposal of all written communication as prescribed under "SEVOTTAM Scheme".

(b) The Commissioner, Central Excise, Rajkot is designated as "Public Grievance Redressal Officer" for cases received in Commissionerate HQ Office. Similarly, for cases received in Divisions, the concerned Divisional Deputy/Assistant Commissioners are designated as "Public Grievance Redressal Officers" for respective Divisions. The concerned Divisional DC/AC may refer such cases to the Commissioner, Central Excise, Rajkot. All correspondence related with Public Grievances and Vigilance matters shall be disposed off within 30 days. File to be submitted to the Commissioner on every 15th & 30th day of the month by Vigilance Section, HQ.
